What is planned giving?

Planned giving is philanthropy combined with smart financial planning. It helps you make the most of your assets during your lifetime and helps you make future charitable gifts that are often much larger than you may have thought possible. Planned gifts use financial, estate and tax planning techniques that can lower your income and estate taxes, and reduce (or eliminate altogether) capital gains taxes.



Who decides how my gift will be used?

You do. When you create a legacy plan with MCF, you outline how your future gift will be used to benefit the causes you care about most. Your gift can create or grow your named fund, and you may designate successors to advise your fund and recommend grants annually. You may also designate specific charities, field of interest funds or other existing funds at MCF to receive annual distributions from your fund.

Or, if you would prefer to take advantage of MCF's deep knowledge of the community to direct your grantmaking, you can make a gift to the Priority Fund, directed to address the community's most pressing priorities, or the Community Impact Fund, which supports MCF's grantmaking program.

How much money do I need to give?

Donors can leave gifts of any amount. There is no minimum for gifts made as unrestricted or for existing funds such as your named fund, or MCF's Priority or Community Impact Funds. The minimum amount to establish a new endowed fund is \$15,000 for individuals and \$100,000 for a named field of interest fund.

How long will my named fund last?

Your personal legacy lasts forever. MCF endowments are carefully invested to achieve long-term growth and perpetual distributions to benefit causes and future generations.

How do I make a planned gift to MCF?

The simplest way to make a planned gift is to list Madison Community Foundation as a beneficiary of your retirement assets or life insurance policy. You may also leave a planned gift by including specific language in your will or trust, such as:

I/we bequeath to Madison Community Foundation (tax ID# 39-6038248), located in Madison, Wisconsin, _____ percent of my/our residual estate - OR - the sum of \$_____ to be used for charitable purposes set forth in a *Statement of Intent* or *Letter of Understanding* held by Madison Community Foundation.

Once you've arranged to make a planned gift to MCF – let us know! We will work with you to document specific ways you would like to make a difference through your gift and how you would like to be recognized. This information may be updated at any time without needing to revise your will. We will also invite you to join MCF's Legacy Society.

What is the Legacy Society?

The Legacy Society is a special group that acknowledges and honors individuals and couples who have made the meaningful decision to leave a gift to MCF in their will or estate plan. Member benefits include invitations to special programs and events, acknowledgment in our annual report and other publications, and more. Donors may also choose to remain anonymous.
